In the spring of this year we had correspondence concerning an individual by the name of Thomas J. Perrucci. You had asked that we place this individual on our Confidential File so that he could not be registered with the Boy Scouts of America.

At that time, your correspondence indicated that he was under active investigation for criminal charges. We would like to know whether or not he has been indicted and whether a trial has been held. If there has been a conviction we would also like to know the outcome and the sentencing. This will strengthen our file in refusing future registration wherever Mr. Perrucci might live.

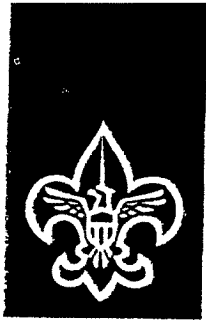

January 24, 1983

██████████ of Big Brothers/Sisters of Wayne told David Baur that there was a leadership problem with one of our Scout Leaders. He, Mr. ██████████, was told by the Bergen County Prosecutor's office that Mr. Perrucci was a known member of the Man-Boy Love Association. Mr. ██████████ also made Mr. Baur aware of his criminal record.

January 27, 1983

Met with Lt. David Mihok of the Mahwah Police Department. Lt. Mihok is the juvenile officer who is familiar with Mr. Perrucci's record. He shared with me his record which is briefly outlined as follows:

1976 - Convicted of possession of stolen property; suspended sentence; probation - 1 year

1979 - 1980 ... Three summons for loud music; noise complaint for neighbor; fine only

Lt. Mihok said Mr. Perrucci was under active investigation by the Bergen County Prosecutor's office for being suspected of membership in the Man-Boy Love Association and other possible criminal charges.

February 1, 1983

Met with Mike Trahey & Roger Stone of the Bergen County Prosecutor's office and Dave Baur. They reviewed Mr. Perrucci's file and indicated they had definite proof, including pictures, that Mr. Perrucci was a member of the Man-Boy Love Association. He is also under active investigation for criminal charges.
