Sexual Assault Brings 5-Year Term

BARRE — Bert Stevens, 51, of Burlington has been sentenced to serve five years of a nine-to-15-year jail sentence on a charge of sexual assault on a juvenile.

Stevens pleaded guilty Tuesday afternoon just before a trial was scheduled to begin, Washington County State's Attorney Terry Trono said.

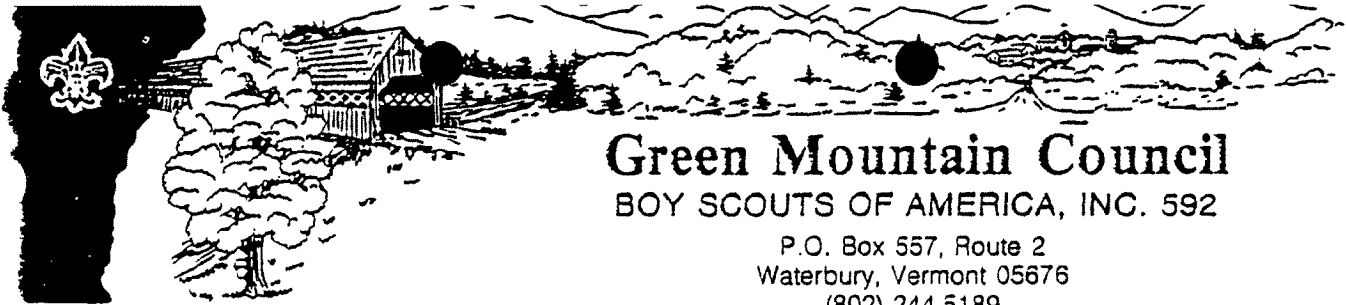
Conditions of his eventual parole will include counseling and a prohibition on unsupervised contact with minors, Trono said.

Stevens was accused of sexually

assaulting four males, age 9 to 13, at the Highgate Apartments in Barre, where Stevens lived for two years. He pleaded guilty to one count, Trono said.

Stevens took a leave of absence as manager of Burlington's Northgate Apartments after he was charged, police said.

While living in Barre, Stevens was a scoutmaster of Troop 13. According to police, some of the instances of sexual abuse occurred during Scout outings in New Hampshire and the Burlington area.



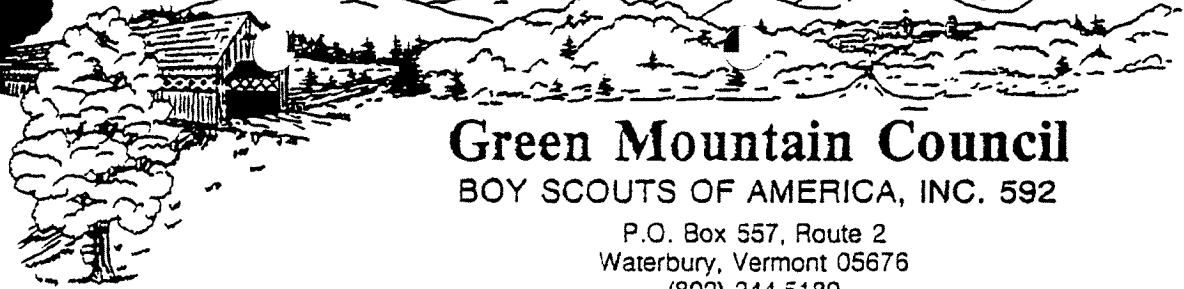



Faces Sex Charges

Bert Stevens, 51, manager of Northgate Apartments in Burlington, is scheduled to be arraigned in Vermont District Court in Barre Aug. 1 on a charge of sexual assault on four juveniles, according to the Washington County prosecutor.

Terry Trono said Washington County officials are working with Burlington police and New Hampshire authorities investigating possible violations in their jurisdictions.

Trono said investigation has revealed that the four boys, ages 9 to 13, allegedly were molested during a two-year period when Stevens and his wife, Jeanette, lived at Highgate Apartments in Barre.

Attempts to reach Stevens and his attorney, Peter M. Cleveland of Shelburne, during the weekend were unsuccessful. Cleveland has an unlisted home phone number.

The state's attorney, who is guiding the investigation, said Robert Belenky, a Marshfield psychologist, brought the allegations to the attention of police. Belenky runs a counseling service for chil-

dren.

Trono said the investigation began about four weeks ago and by the end of last week it was determined there was enough evidence to order Stevens into court.

Trono said that while Stevens was identified immediately as the prime suspect, authorities did not want to arrest him because they would have been unable to discuss the case with him afterward.

Stevens is a coach for a youth hockey team in Burlington and previously was scoutmaster for a now-defunct troop in Barre, Trono said.

Trono said the investigation has been slowed because it included alleged incidents outside Washington County. He said some incidents are said to have occurred on camping and swimming trips.

Burlington detectives said their investigation is continuing. Detective Lt. David Demag said the city may wait to see the outcome of the Washington County cases. Chief Deputy State's Attorney Susan L. Fowler has been working on the case, according to Detective Cpl. Richard Rowden.
