The cousin was placed in a room by himself. Rick came in later and made sexual advances.

██████████ - told his mother that Rickey tried to touch him in the genital area.

Rick has listed 2 boys-██████████. and ██████████ into the Order of the Sword - which is supposedly a National organization of which Rick is in charge of this area. ██████████ was told by his son, ██████████ that the introduction of the first degree was to shower with Rick and wash each other. He had issued certificates and medals to each.

Dear Paul,

I have been informed that the Scoutmaster of Troop 241, Uwharrie Council #419, has been removed from his position by the Troop Committee. This action has been taken because of numerous, specific charges of homosexual conduct leveled by youth members of the troop.

I am convinced that the actions of the Troop Committee are justified and that the leader, Rickey Martin Vernon, does not meet the Standards of Leadership of the Boy Scouts of America.

I request that the registration of Rickey Martin Vernon be suspended and he be denied the privilege of registration with the Boy Scouts of America.

Troop 241 is a newly registered troop in the Uwharrie Council, (December 1982). The Troop Committee has selected a new Scoutmaster, Michael Lewis that registered with the Troop as the Committee Chairman. He will serve as the Scoutmaster giving the leadership position of Committee Chairman to Ned Craver along with Scouting Coordinator of the Troop. (Application for Michael Lewis is enclosed).
