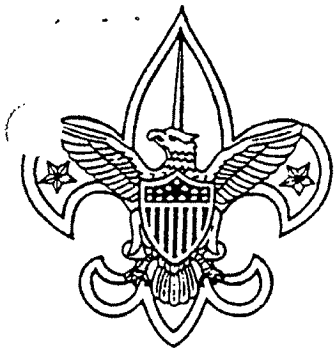

On 6-5-83 at 11:50 PM, suspect Thomas R. Warren was interviewed at the Palm Beach Co. Sheriff's Office Headquarters and confessed to performing oral sex on juvenile victim [REDACTED] W/M DOR 12-15-70 between approximately June, 1982 and June, 1983 while [REDACTED] was taking a shower with Warren at Warren's residence of 6132 Haddon Rd., West Palm Beach. This confession was further confirmed by statements obtained in an interview by this detective with victim [REDACTED] on 6-5-83. Suspect was also involved in an incident of mutual masturbation with [REDACTED] that occurred on 6-5-83 at approximately 10:00 PM. This incident was also confirmed by both suspect Warren and victim [REDACTED]. The latter incident occurred in suspect Warren's 1975 Plymouth Valiant parked in the Banyon Lakes development west of West Palm Beach.
