Indecent liberties 5-25-83

A Rockford man was charged with aggravated indecent liberties with a minor following an investigation, Rockford police said Tuesday.

Robert Haber, 27, 3023 La Salle Ave., was arrested at his home Tuesday morning.

Police said Haber is a scoutmaster, but did not give any details of the alleged incident. Tuesday night Haber was lodged in the Winnebago County Jail in lieu of \$50,000 bond.

Police continue investigation 5-27-83

Police continued their investigation Thursday into the incidents that led to a charge of aggravated indecent liberties against a Rockford man.

Robert Haber, 27, 3023 La Salle Ave., remained in the Winnebago County Jail on Thursday night with bond set at \$50,000. He was arrested Tuesday after a police investigation linked him with an incident involving a Rockford boy.

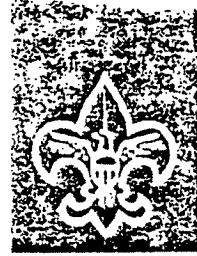
Police said Haber was a program director and Scout program coordinator at the Jewish Community Center, 1502 Parkview Ave., at the time of his arrest and he had used his position in Scouting to meet the child with whom he is accused of taking indecent liberties.

We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.
