Officer charged with misconduct

A former police officer was charged with misconduct

that occurred on Monday afternoon last, involving a 15-year-old boy during a camping trip to Mandala Boy Scout Camp between Jackson and Grove Hills. He was charged with making harassing telephone calls to the same boy in violation of an order by the Mobile County Sheriff's Department. Donald C. K. Brooks, chief of the Sheriff's Department, was released on \$500 bond pending a hearing before the grand jury of the Clarke County Grand Jury.

According to Clarke County Sheriff's Deputy Frank Day, Brooks came to the camp site about midnight, asking for a boy named by name. Brooks told the boy he was being taken for some of the
