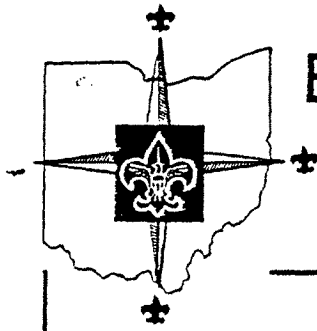



At this time we wish to inform you, effective immediately, that your services are no longer needed, nor will they be accepted as an adult leader or member of Troop 300.



Dear Mr. Ashbrook:



We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the Boy Scouts of America seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.

This is in regard to Dexter Ashbrook and my two sons, [redacted] who belong to troop 300

I have witnessed Dexter out of control, not just a temper fit, but struck me more as a jealous rage. Just because two brothers and my son [redacted] and his girlfriend went to the movies. This is when I began to realize that there might be a problem with Dexter. I requested that Dexter be kept away from my son at scout meetings and scout functions. My youngest son, [redacted] tells me that he is glad Dexter won't be around them because he (Dexter) is always wanting to hug him and pull him close to him. [redacted] has also stated that Dexter has tried to hug him.

Dexter came to me very upset because I wouldn't allow them around my sons.

We talk and he tells me some things from his past, which I found disturbing. He also proceeds to tell me, and I quote him on this:

"I shouldn't tell you this, (makes this remark to me 3 times before he continues). but I love [REDACTED] this remark I will never forget. I believe Kester meant exactly what he said and it wasn't like a father loving a son.

Because [REDACTED] wasn't doing exactly what he thought he should be doing, he threatens him by telling him that if he doesn't do right he will fix him so that no one will ever have anything to do with him again.

I got to know him better when he started taking me to movies that I wanted to see,
