Term: 5 years commencing 4-2-84

IT IS ORDERED that the Defendant be placed on probation under the supervision of the above-named probation officer for the term indicated and the Defendant shall:

1. Not violate any criminal law of any unit of government.
2. Not leave the state without the consent of this court.
3. Make a truthful report to the probation officer either in person or in writing, monthly or at such times and places, or as often as the probation officer may require.
4. Pay such monies as appears in this or any amended order by cash or money order payable to the Branch County Clerk, Courthouse, Coldwater, MI 49036 in the amount, at the times, and for the purposes herein prescribed.
5. Live in an approved residence and shall not change that residence without prior permission of the Probation Agent.
6. Make a conscientious effort to find and maintain legitimate employment unless engaged in an alternative program of school or training which has been approved by the Probation Agent. The probationer will notify the Agent of any changes in his/her employment, school or training within one working day of such change.
7. Voluntarily seek and participate in a treatment program as recommended by the Probation Agent.
8. Not be in the company of male minors.
9. Forthwith be confined in the Branch County Jail for a period of one (1) year with credit for 1 day already served.
