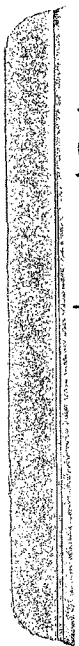

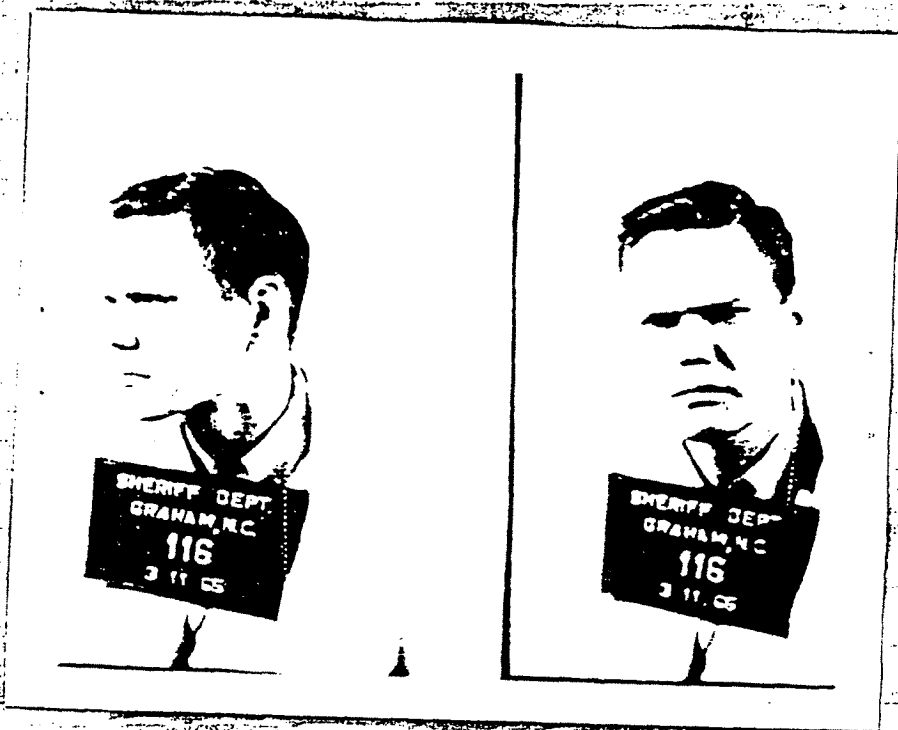

Charles M. Vebaun, 37, W, M
Name, Age, Sex and Race of Defendant

In open court, the defendant appeared for trial upon the charge or charges of Taking Indecent Liberties with a Minor

and thereupon entered a plea of not guilty. Defendant appeared with counsel. A jury was selected and empanelled as appears of record. After hearing the evidence the jury returned a verdict of guilty as charged.

Having been found guilty of the offense of Taking Indecent Liberties with a Minor

which is a violation of G.S. 14-202.1 and of the grade of felony.

It is ADJUDGED that the defendant be imprisoned for the term of Ten (10) years in the North Carolina Department of Correction. The defendant has 3 previous convictions of Taking Indecent Liberties with a Minor. It is ordered that the defendant be given credit for 13 days spent in custody pending trial.

It is ORDERED that the Clerk deliver two certified copies of this judgment and Commitment to the Sheriff or other qualified officer and that said officer cause the defendant to be delivered, with such copies as commitment authority, to the appropriate official of the State Department of Correction.
