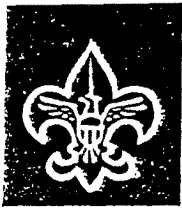



Andy Moore, after being charged with statutory rape, is currently scheduled for trial in March. A true bill of indictment is being returned, as there is sufficient evidence to prosecute Moore. Moore was discovered in Louisiana in late October and brought back to McDuffie County, where he was held in McDuffie County Jail. His wife has been located and arrested on the same charges of statutory rape. The court is in the process of extradicting her.

Moore's Bond Set At \$100,000

Andy Moore, after being charged with statutory rape and being advised of his rights, elected to waive his right to a preliminary hearing, Oct. 30.

Moore, currently being held in McDuffie County Jail on that charge. Sheriff William Swan anticipated other similar charges will be brought against the defendant, eventually.

Moore had sexual intercourse with a 13-year old girl (which signifies statutory rape) and got her

pregnant, which led to an abortion.

Moore left McDuffie County the day before the warrant was to be issued on him, leaving many personal belongings. This indicated he left in a hurry and knew about the warrant.

It was rumored Moore had been in Virginia, Texas and Florida. Sheriff Swan brought him back from Louisiana on Oct. 25 and he is now being held on a \$100,000 bond. Moore will face the grand jury, Dec. 10.
