# Shelby Man Faces Two Sex Charges

SHELBY—A Shelby man, charged with two counts of criminal sexual conduct, third degree, remains free on bond today, after posting a \$10,000 surety bond.

He is identified as Ernest Glover, 57, of Pine St., Shelby. A preliminary examination was set in district court for April 6 at 9 a.m., and another, on the second charge, on April 19, at 10:45 a.m.

The charges were lodged by troopers from the Hart Post of the Michigan State Police and the Oceana County Department of Social Services, following two alleged incidents last month.

# Tornado Policy Issued By City Schools

...g of spring, the chance for tornadoes concern. The schools of the Mason-Lake following a unified tornado policy. follows: when a TORNADO WATCH is S. Weather Bureau, it covers a large hical area indicating conditions might develop that could produce a tornado.

In the event school is in session and a WATCH notice is issued, schools will be dismissed as soon as possible. In most schools it takes about an hour to call drivers in, load students, and have them on the road home. School dismissal notices will be announced on the local radio stations. Parents are urged not to call their child's school unless absolutely necessary.

If a TORNADO WARNING is issued by the local weather authorities, Civil Defense or the sheriff department, it means a tornado has been sighted in the area. In the event school is in session and a WARNING signal and students will be directed by staff to the area in the school building that has been designated as the safest shelter area.

HART—Ernest Glover, 57, of Pine Street, Shelby, pleaded guilty to the charge of criminal sexual conduct, second degree, recently during his circuit court arraignment in Oceana Circuit Court.

A second charge of criminal sexual conduct, third degree, was dismissed.

The alleged incident involved an Oceana County girl under the age of 13 in November 1983.

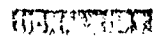
