Scoutmaster quits; was once child abuser

The scoutmaster of the Manson Boy Scout troop resigned this week after it was disclosed that he had pleaded guilty earlier this year to a charge of lascivious acts with a child.



But John F. Carter, 41, of rural Manson said the incident occurred more than two years ago and he has since undergone therapy with a Fort Dodge psychiatrist and the Iowa Department of Human Services, and was released by both.

Carter said Thursday that he only volunteered to be Scoutmaster because no one else stepped forward to take the job.

"This year it came to a point where they didn't have a Scoutmaster to take it over," Carter said. "If I hadn't taken it, nobody else would have."

Court records show that Carter was charged Nov. 29, 1982, in Pocahontas County with lascivious acts with a

child under age 14 in connection with an incident in July 1982. After entering an initial plea of innocent on Dec. 13, 1982, he pleaded guilty in January 1984 and was given a deferred sentence with a year's probation. Counseling was ordered.

Pocahontas County Attorney H. Dale Huffman said Carter "apart from that," has been "a model citizen as far as I know ... I don't harbor any resentment toward this person because of the act."

Huffman said Carter "appears to be well-rehabilitated and has demonstrated genuine remorse for what happened."

Huffman would not release any further details on the incident in which Carter was charged.

Carter said he was named Scoutmaster only five weeks ago, but his son and stepson have been involved in Scouting for more than a year. Since resigning, he said, he's talked to several of the boys and "every one of them

said, 'Boy, I wish you were still going to be Scoutmaster.'"

Carter's role in the Boy Scouts came to official attention two weeks ago, when Manson Assistant Police Chief Kevin Benson saw him driving a truck on a scout paper drive. Benson said he was told by a Department of Human Services worker about Carter's record several months before.

"I was appalled," Benson said. "Whoever would recommend this guy to be around young children should have his head examined."

Police notified the Rev. Gregg Davison, pastor of the Augustana Lutheran Church in Manson, and the Rev. Bob Hempel, pastor of the Manson United Church of Christ. The two churches have held the troop's charter since this fall.

Davison said he and Hempel talked to area Scout officials, who asked Carter to resign Tuesday. "It's been a tough situation for everybody," said Davison.

PROBATION AGREEMENT

CR15-1182

TO ALL TO WHOM THESE PRESENTS MAY COME:

I, John Carter, having been granted probation on the 30th day of January, 19 84, by the District Court, Pocahontas County, Iowa, Criminal Number CR15-1182 for the offense of Lascivious Acts w/a Child and under sentence of Deferred, 2 yrs Probation with the further order of the Court being that I be placed under the supervision of the Second Judicial District Department of Correctional Services, as provided by Chapter 907 of the 1979 Code of Iowa, do hereby agree that I will be subject to the following terms and conditions as set by the Court and the Department of Correctional Services.

- I will abide by any and all conditions of probation set by the Court in pronouncing judgment in this case.
- I will obey all laws, whether they be Federal or State laws or City ordinances. I will contact my supervising officer upon any arrest as soon as possible but no later than seventy-two (72) hours after that arrest.
- I will initiate and maintain contact with my supervising officer at least monthly, or as often as directed by that officer. I will notify that officer in advance if I cannot keep any appointment.
- I will secure and maintain employment as approved by my supervising officer throughout the time that I am under supervision. I will not change employment without prior approval from that officer, and I will notify that officer as soon as possible but within seventy-two (72) hours if I lose such employment.
- I will maintain suitable residence as approved by my supervising officer throughout the time that I am under supervision. I will not change residence without prior approval from that officer, and I will notify that officer as soon as possible but within seventy-two (72) hours if I change my telephone number or service.
- I will actively cooperate with and participate in any programs to which I am referred by my supervising officer.
- I will not leave the territorial limits of Pocahontas County, Iowa, without obtaining prior permission from my supervising officer. I will not leave the territorial limits of the State of Iowa without obtaining the prior written permission of that officer. (I understand that I must notify my officer one (1) week in advance in order to obtain out-of-state travel permission.)
- I will ~~completely abstain from~~ (limit) the use of alcoholic beverages. I will not use any drugs unless prescribed for me by a physician and will not use or possess any illegal drugs or any prescription drugs for which I do not have a valid prescription. I will submit to urinalysis and/or alcohol testing upon the request of my supervising officer.
- I will not own, possess, carry or use a firearm or other dangerous weapon as defined in Chapter 702.7 of the 1979 Code of Iowa.

SPECIAL CONDITIONS 1. defendant shall continue counseling with Berryhill & Associates, Ft Dodge and follow through with all treatment plans recommended; 2. Defendant shall continue working with the Department of Social Services and follow through with all recommendations; 3. Defendant shall pay the costs in this matter.
