the Iowa Department of Corrections for an indeterminate term not to exceed five years.

Defendant's appearance bond is exonerated.

The temporary custody of the Defendant shall remain with the Sheriff of Linn County pending Defendant's transfer to the custody of the Director. Linn County shall pay the costs of temporarily confining the Defendant and transporting the Defendant to the state institution where he is to be confined in execution of this judgment.

This Court recommends that the Board of Parole follow its usual rules, regulations and guidelines in determining when the Defendant would be eligible for release or parole.

The Defendant is given credit for 103 days served on this charge.

The Defendant is taxed the costs of prosecution.

The Defendant was advised of his right of appeal. Appeal bond is set in the sum of \$5,000.00.

Sentencing was entered pursuant to Rule 9, the Court agreeing to be bound by the terms of a plea agreement. The Court and the State recommend that Defendant be incarcerated at a state institution such as Clarinda.

Police arrested a 38-year-old Cedar Rapids man Wednesday and charged him with having illegal sexual contact with three young boys.

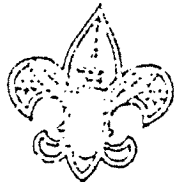

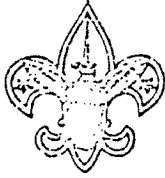

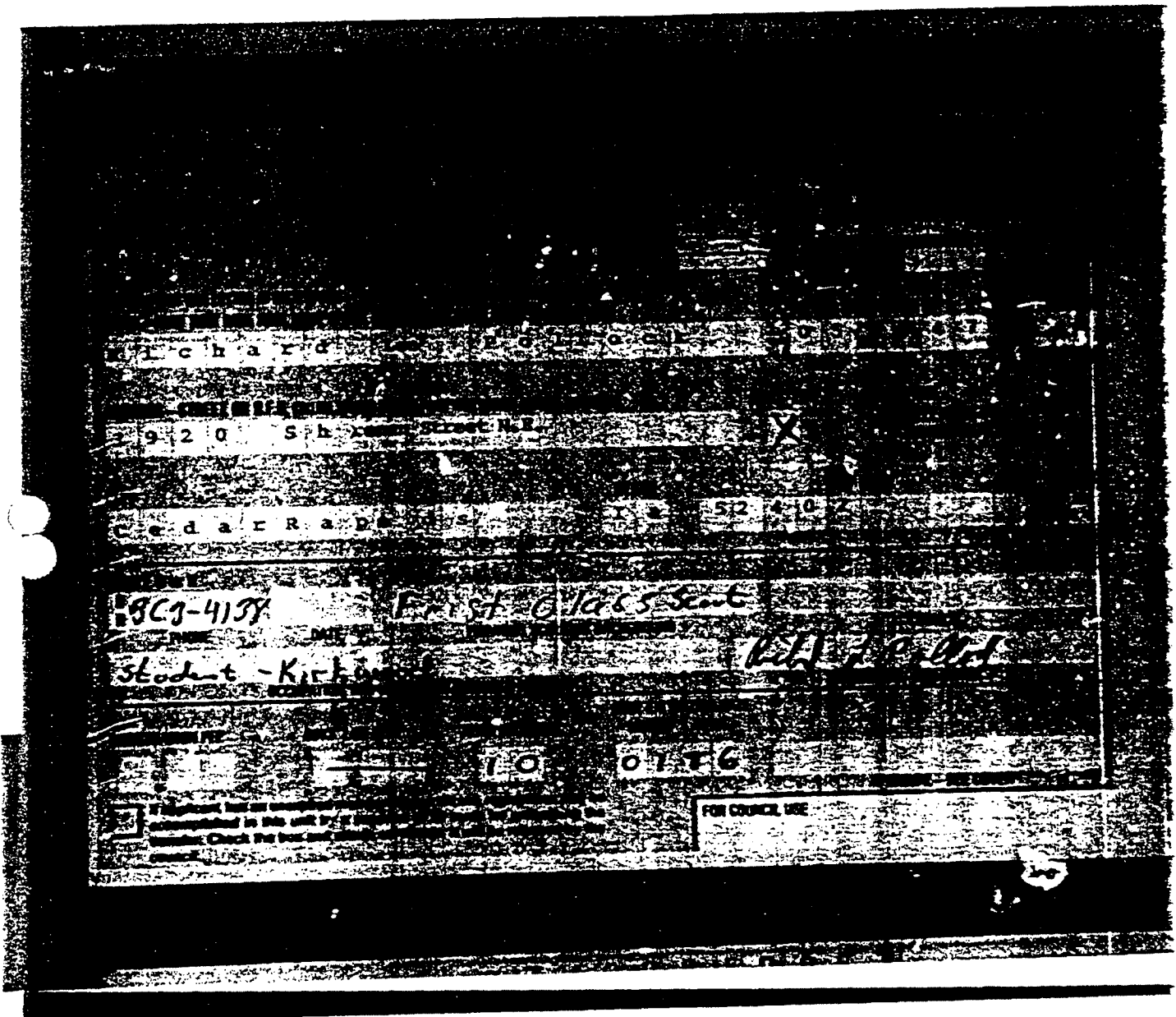
