## Boy Scout Leader Pleads Innocent

BURLINGTON (AP) — A Boy Scout leader has pleaded innocent to fondling two scouts last year.

Randall J. Newcity, 35, of North Avenue pleaded innocent in Vermont District Court Monday to two charges of lewd and lascivious conduct with children.

Newcity was the leader of the Webelos in Boy Scout Troop 41 at St. Mark's Church when the alleged incidents occurred, court records said.

According to court records, Newcity is accused of fondling one Scout at four Webelos pack meetings held in Newcity's home during the fall of 1983, and of fondling a boy at his home and during a camping trip.

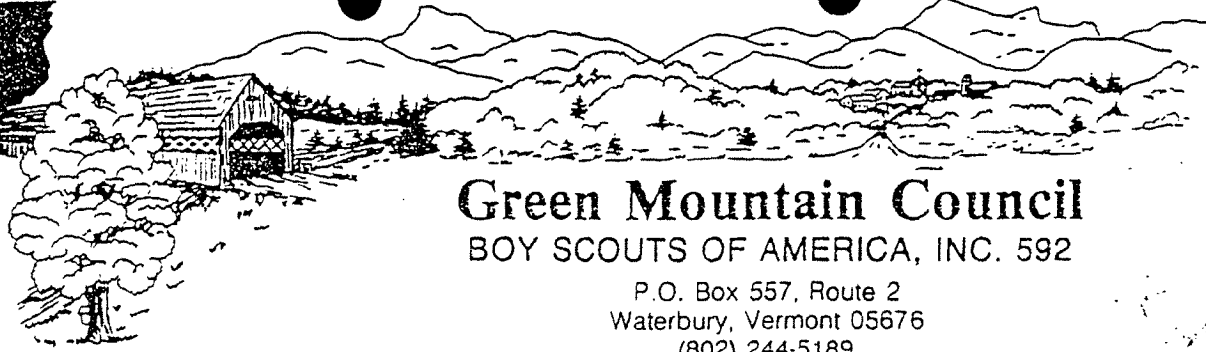
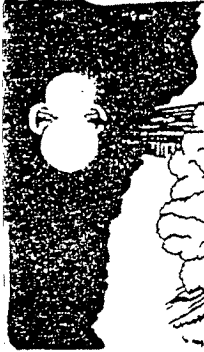
Newcity was released pending trial, court records said.


