Dear Sir:

From October 1970 through Feb. 1971 we heard some rumors that one of our former Scoutmasters has had some deviate sex behavioral problems with boys. We were not able to determine the validity of these fragmentary stories until Feb. 1971.

At this time two boys in Cody, Wyoming, talked to their parents who in turn confronted the suspect. He confessed to them and also to me when I visited with him on Feb. 24, 1971. He told me of the problem he had had in Cody, and that he was receiving professional help and also working with his clergyman.

We discussed the problem in the council staff meeting and arrived at the conclusion that as he had made steps toward correcting the problem that we would keep a vigil and if he showed sign of returning to these problems we would then contact the personnel division.

I was informed by an attorney on May 24th, 1971 that Ernie had again had a problem with a Cub age boy and that the parents had filed a formal charge against him and that he was arrested.

With these new developments we feel that now is the time to have his name placed on the Confidential List. L. Ernest Martinez was a member of the Koshare Indian troop in La Junta, Colorado, as a boy. He is an Eagle scout and has held several volunteer positions, usually as a Scoutmaster. He served in this capacity in Troop 34 Basin, Wyoming, and in Troop 40, Greybull, Wyoming. He answers to the name of Ernie and is 6 feet, 210 pounds. His residence during 1969-1971 was at 325 3rd Ave. S., Greybull, Wyoming, 82426.
