Cumberland grand jury indicts 35

CARLISLE — Thirty-five persons have been indicted by the Cumberland County grand jury following three-day jury sessions.

The jury was meeting to review cases listed for the September term of criminal court. The following persons were indicted:

Dennis Stine, no address given, burglary, larceny, conspiracy and receiving stolen property; William S. Miller Jr., of Carlisle, larceny; Russel S. Mitchell, of Carlisle, burglary, possession of burglary tools.

Spencer L. Carey, of New Cumberland; Robert A. Huitt, of Harrisburg; Larry E. Sheriff, no address given; Earl Miller, and Henry Swartz Jr., of Millerstown, all charged with larceny.

Charles J. Burns, of Mechanicsburg, larceny by employe; Christopher Schurtz Jr., and Donald D. Schurtz, both of York Haven, larceny of electric equipment; Larry S. Perva, no address given, prison breach, larceny of motor vehicle and larceny.

James E. Cool Jr., of Dallastown, burglary, larceny; Harry P. Bevan, of Mechanicsburg, conspiracy, burglary, and larceny from the person; David J. Buddy, of Coraopolis; James A. Paine, of Aliquippa; and William C. Minch, of Coraopolis,
