Kim Morgan Harper, whose registration card is enclosed, has been removed from his position as ASM of our Troop 471. The reason that necessitated this action became clear after he had been told by volunteers within the unit to resign or suffer the consequence of formal legal action.

Further investigation by our office revealed that Mr. Harper has a police record with the Cypress Police Department (petty theft, theft and assault) and the Buena Park Police Department (sexual perversion). He is on probation regarding these offences. The probation officer referred to the need of "intensive psychiatric help".

Harper was born December 13, 1951, has blond hair, weighs 150 lbs. and is approximately 5'11" tall.
