


I regret to find that an undesirable individual has been registered in Troop 7, District 3, Council # 741.

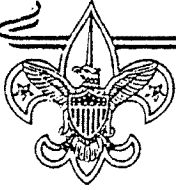

I have your letter of December 16 concerning Oliver Carl Chandler. Attached is a confidential record sheet which we would appreciate your filling out as completely as possible. This is our main means of identification, should Sgt. Chandler attempt to register in the future from some other council.

The only information you have provided in your letter is that there was a confession of homosexual activity. Do you have any more details than this single statement? Do you have the confession in writing? If so, we should have a copy. Can you obtain any statements from parents or boys?

What I'm driving at is that if we refuse this man registration in the future, and he makes an issue of this refusal and takes us to court, we have to have substantial information in our files to back up our refusal of his registration.

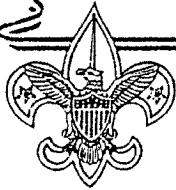

We regret to inform you of the confession of homosexual activity on the part of Sgt. Oliver Carl Chandler of 1415 Martin St., San Angelo, Texas. Mr. Martin is registered as a Webelos Leader in Pack 304 and a Troop Committeeman in Troop 7.

Mr. Chandler is married, about 5'6" tall and weighs about 150 pounds. His age is 33. He has light brown hair, but is balding rather rapidly.

He has three sons active in the Scouting program ages 8, 9 and 11.

The time of the offense was approximately a month ago and the confession was in the office of the Asst. District Attorney. Also present at the time of the confession was the father of the abused boy and the attorney for Mr. Chandler.

We know you will follow through. Thanks very much.
