

I WOKE UP IN THE MIDDLE OF THE NIGHT AND REALIZED THAT HERB WAS HOLDING MY SEXUAL ORGAN. AT FIRST I WAS TOO GROGGY TO DO ANYTHING, BUT FINALLY ROLLED OVER AND HE LET GO. IT IS MY OPINION THAT HE WAS ASLEEP DURING THE WHOLE INCIDENT.

THIS IS THE ONLY THING OF THAT NATURE, TO HAPPEN TO ME ON THE WHOLE TRIP BACK AND FORTH WITH HERB.
