Prison Term in Molesting Case

Arthur G. Harper, 40, of 278 Webster Ave., was sentenced yesterday by County Judge Edward O. Provenzano to up to seven years at Attica Correctional Facility in a case involving the molesting of two boys. Harper had been permitted to plead guilty to a reduced charge of second-degree sodomy.

Authorities reported that the attack, which occurred last April 21, involved a six-year-old boy and a nine-year-old boy.
