The information as shown is believed to be very accurate but isn't complete.

As no one knowledgeable concerning the situation is willing to give us a written detailed letter for future reference, we'll have to refer to the arrest records of Coos County in the county seat of Coquille as per my reference in my original letter to you on August 10, 1972.

We are sorry to notify you that we have been advised by the District Attorney's office for Coos County, Coquille, Oregon, that Mr. Frost was arrested July 3, 1972. He is currently awaiting trial after pleading guilty to charges of:

- a) Two counts of sodomy in the 2nd degree.
- b) One count sodomy in the 3rd degree.
- c) Two counts of sexual abuse in the 2nd degree.

The District Attorney's office has further advised us that a Psychiatrist report on Mr. Frost shows him to be a "sexual deviate attracted to young boys and young homosexuals".

We have removed Mr. Frost's name from our mailing lists and are taking steps to secure registration of his replacement. There has been excellent cooperation between the sponsoring institution (Lions Club of Powers) and our District Executive.
