Enclosed is a confidential record sheet which we would appreciate your filling out and returning to us as soon as possible, together with the above information.

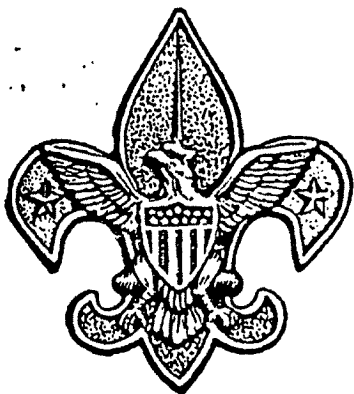

[REDACTED] stated that [REDACTED] and himself had gone to Robert Dolong's cabin to do some work and he was to get paid for it, the first night there Robert showed a stag movie, the name of it was "Cindy & Dan", after the movie Robert took his pants down and asked me to jack him off, I said no, he asked me a couple times, I told him to do it to himself, he told me if I would do it to him he would give me a dollar, I needed the money so I did it, he then did it to me, we did this every night from then on. [REDACTED] did it to Robert and Robert did it to him. We also had all the beer we wanted to drink.

I explained the court procedure to [REDACTED] Mrs [REDACTED] and if there was charges pressed it would have to be from the county the incident happened, she felt that something should be done and would go along with any action taken.

Nature of Complaint Indecent Liberties with a Minor Child

CONTINUED INVESTIGATION:

On 7-11-72 at about 11:15 am I went to the [redacted] residence and talked with Mrs [redacted]. I explained the complaint to her and she stated that she had heard about what had happened but [redacted] did not want to talk about it, I asked her if I could talk to [redacted] alone and she said yes.

When I first started to talk to [redacted] he did not want to talk about it, I explained to him that he wasn't being charged for any thing but we were here to investigate whether he was for the indecent liberties that was taken with two boys who are under age.

[redacted] then stated that on the first night Robert Dolong showed a movie, it was a guy and a girl, they never had any clothes on and they were doing things to each other, he couldn't remember the name of the movie, after Robert showed the movie he took his pants down and wanted [redacted] to jerk him off, [redacted] would do it, he told Robert to do it himself, Robert kept asking [redacted] and then offered him a dollar, so then [redacted] then did it, after [redacted] did it to Robert then Robert did it to Daniel. One night after we went to bed Robert and [redacted] had all their clothes off, Robert had [redacted] lay on his stomach and then Robert got on top and went up and down like they did in the movie. One night Robert done it to me, he kept rubbing the head until I opened.

Robert gave us all the beer we wanted, he bought it at the store. I asked [redacted] why did [redacted] do it to Robert so many times?, he said that Daniel wanted a mini bike and needed the money.
