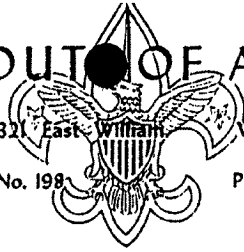

NOW ON THIS the 24 day of February, A. D. 19 71, in the above styled and numbered cause came the State by its District Attorney, and came the defendant, JAMES BOARDMAN, in person, his counsel also being present, and there came on for consideration by the Court the application of said Defendant for probation, and the parties being ready thereon, the Court duly considered said application, and the evidence with respect thereto, and the statements by both the State's Attorney, and the Defendant in person and by his counsel, and it appearing to the satisfaction of the Court that the Defendant has been convicted herein of the offense of Fondling and his punishment assessed at confinement in the State Penitentiary for a term of 2 years, and that such offense is one for which the law permits probation, and the punishment assessed is within the term for which probation is allowed by law; that the Defendant is eligible for probation, and that the ends of justice and the best interest of the public as well as of the Defendant will be subserved by granting probation; and it appearing that sentence has not been imposed upon such conviction, it is found that same should be suspended, and the Defendant placed on probation under the terms of law and the further provisions hereof.

It is, therefore, ORDERED, CONSIDERED AND ADJUDGED BY THE COURT that the Defendant James Boardman, be and he is hereby granted and is placed upon his probation in respect to said conviction, and that the sentence herein imposed be suspended for and during the next ensuing Two years, provided, the said Defendant shall comply with all the conditions of law and of this order governing such probation.

It is further ORDERED by this Court that the Adult Probation Officer of Bell County, Texas be, and he is hereby appointed as probation and parole officer to supervise the Defendant in this case while on probation hereunder.

It is further ORDERED that the Defendant shall, during the period of probation and parole herein fixed, comply with the following conditions and terms of probation, viz:

- (1) Defendant will not violate the laws of this state, any other State or the United States and his behavior will be good.
- (2) Defendant will be gainfully employed.
- (3) Defendant will report to said Adult Probation Officer as directed by the Court.
- (4) Defendant will remain within the limits of Bell County, Texas, and change place of residence only with permission in writing from the Court.
- (5) Defendant will pay \$150.00 Cost through said Adult Probation Officer as directed by the Court.
- (6) Defendant will pay \$10.00 per month as costs of administration of this probation to said Adult Probation Officer. The first such payment to become due on the 24 day of Feb, 1971, and a like payment on or before the 24 day of each month thereafter throughout the term of this sentence unless legally terminated.
- (7) Defendant will pay to said Adult Probation Officer restitution in the amount of \$ for the benefit of the injured parties as directed by the Court.

It is further ORDERED by the Court that the foregoing terms and conditions of probation and the period of the same may be altered, modified, changed or terminated at any time by the Court.

And, thereupon, the Court informed the Defendant that he had a right to appeal his conviction herein to the Court of Criminal Appeals at Austin at this time if he wished to do so, and the said Defendant then and there in open Court, in person, informed the Court that he did not wish to appeal the same, and waived the right to file a motion for a new trial or to appeal the conviction herein.

And, the foregoing terms and conditions of probation having been made known to the Defendant in person in open Court, he, said Defendant, then in person voluntarily assented and agreed to the same and bound himself to comply with the same.

Whereupon, it was the further order of the Court that the Defendant be now released from custody upon probation and parole as herein provided for.



And the Grand Jurors aforesaid, upon their oaths aforesaid in said County and State, at said term, do further present in and to said Court that before the presentment of this indictment, in the County of Bell and the State of Texas, on or about the 23rd day of January, A.D., 1970, James Boardman did then and there with lascivious intent entice, allure, persuade and invite [redacted] a male child under fourteen years of age to enter a sleeping bag for the purpose of an act which constitutes the offense of sodomy.

And the Grand Jurors aforesaid, upon their oaths aforesaid in said County and State, at said term, do further present in and to said Court that before the presentment of this indictment, in the County of Bell and the State of Texas, on or about the 23rd day of January, A.D., 1970, James Boardman did then and there by force and threats cause [redacted], a minor, to have carnal copulation with him the said James Boardman in an opening of the body of James Boardman, which was not a sexual part, to-wit: the anus.

And the Grand Jurors aforesaid, upon their oaths aforesaid in said County and State, at said term, do further present in and to said Court that before the presentment of this indictment, in the County of Bell and the State of Texas, on or about the 23rd day of January, A.D., 1970, James Boardman did then and there unlawfully and with lascivious intent knowingly and intentionally place his hand against the sexual part, to-wit: the penis of [redacted] the said [redacted], then and there being a male under the age of fourteen years.
