

PARENTS DID NOT WANT TO PRESS CHARGES AS IT WOULD REQUIRE BOYS IN COURT ETC. ETC.

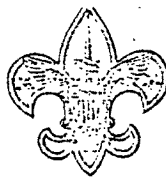

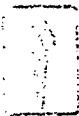

Our investigation of this case leads us to the conclusion that he must be placed in the confidential file.

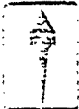


Gentlemen:
