RECOMMENDED FOR CONFIDENTIAL FILE FOR FOLLOWING REASONS: Mike L. Barrett was charged with kidnapping and five counts of Contributing to the Delinquency of a minor. On Saturday, July 14, 1973, he took three Scouts, ages 13, 14, 15, from the Bert Adams Scout Reservation without permission -- took them to a movie -- bought them a steak dinner -- took them to a motel room -- gave them beer. The Sheriff entered the motel room and found two boys in one bed and the third was in bed with Mike Barrett.

On October 9, 1973, Mike Barrett pleaded guilty to the five counts of Contributing to the Delinquency of a minor, and was sentenced to five years -- one to serve in jail and four years probation.

Records of this are on file in the District Attorney's Office, Newton County Court House, Newton, Ga. 30209.







This is to put Personnel Service on notice that Scoutmaster Mike L. Barrett, 2999 Highland Dr., Smyrna, Georgia 30080, age 21 of Troop 732 has been charged with kidnaping (three counts) and Contributing to the Delinquency of a Minor" (five counts) in Newton County, Georgia as the result of an incident on July 14, 1973 at the Bert Adams Scout Reservation.

The Grand Jury on September 28, found a "True Bill" on all counts. The Superior Court will convene on October 9 for the trial.

I wanted your office to be aware of the incident in case you are contacted by other parties. Let me assure you that this office is taking every step necessary involving the incident.

Mr. Barrett has resigned as Scoutmaster and the Institutional Representative has notified this office that Troop 732 has a new Scoutmaster.

As soon as the trial is over, we will make a complete report with all details.
