

SUBJECT: Registration Status

As a result of a complaint regarding the behavior of John Zak, investigation by Tom Cameron, District Executive, revealed that Mr. Zak had been convicted several times on charges of child molesting with the most recent incident being December 29, 1976.

On the basis of the court records we advised on June 3, 1977, Mr. Zak that we could not register him as a Scoutmaster and asked him to discontinue all activities with the Boy Scouts program.

Mr. Zak was advised that he had the right to a hearing by council appointed volunteer Scouters, if he wished to request a hearing in writing.
