8/8/77 - Phone call from [REDACTED] requesting a meeting with the Council Executive.

11:15 A. M. - [REDACTED] and her son [REDACTED] visited Council Office and gave Council Executive report of trip to Nova Scotia. (About same as attached copy of Genesee County Sheriff's Department Supplementary report and voluntary statement by [REDACTED] dated 8/9/77)

8/9/77 - 11:15 A. M. - Council Executive talked with Genesee County Sheriff Roy J. Wullich (who is also District Chairman and Member of Executive Board) about the report from [REDACTED] and her son [REDACTED]

Sheriff Wullich agreed to investigate and assigned Undersheriff R. J. Sheldon and Deputy Sheriff John P. Wilcox to the case.

2:30 P. M. - The Undersheriff interviewed [REDACTED] and her son [REDACTED] (Report attached) and obtained voluntary statement from [REDACTED] (attached).

8/18/77 - Sheriff Wullich met with Council Executive and District Executive Stanley Waters at Council Office and reviewed reports.

Sheriff and two Executives agreed that Lamkin should be invited to meet with Sheriff and Council Executive at Council Office.

8/19/77 - Council Executive phoned Lamkin and requested that he stop at the Council Office for a conference.

1:30 P. M. - LaVerne Lamkin arrived at Council Office and was ushered to Council Executives Office for meeting with Council Executive and Sheriff.

Lamkin was given copy of offence report, supplementary report and voluntary statement prepared by the Sheriff's Department.

Lamkin admitted allowing [REDACTED] to drive car even though he was under-age. He also admitted taking Playboy magazines and wine on the trip which he made available to the 3 boys.



He stated that he was asleep and must have been dreaming in regards to playing with [REDACTED] privates.

Sheriff Wullich explained to Lamkin that [REDACTED] had placed no formal charges against Lamkin at present and presented two options:

- (1) Resign from the Boy Scouts of America or
- (2) If he did not resign, the case would be investigated further.

Lamkin turned in resignation (copy attached).

1. Writer interviewed complainant, who stated her son, [REDACTED] had been sexually abused by one, LAVERN LAMKIN, while on a camping trip to Nova Scotia.
2. Complainant also related her son was told to operate MR. LAMKIN'S motor vehicle to Nova Scotia, during the trip around Nova Scotia and return back to Pembroke.
3. [REDACTED] indicated he drove the vehicle over a 1,000 miles because subject LAMKIN could not operate the vehicle without driving all over the road.
4. [REDACTED] also stated that about the third night of camping he was molested by subject LAMKIN. He woke up and subject LAMKIN was playing with his privates.
5. [REDACTED] related he did nothing at the time but did tell [REDACTED] and [REDACTED] to stay away from LAMKIN, he was queer.
6. After not speaking with LAMKIN for about two days LAMKIN approached [REDACTED] and said he was sorry about the incident and stated he must have been dreaming.
7. [REDACTED] related that there was a couple occasions when LAMKIN would put his hand in [REDACTED] lap when he was operating the LAMKIN vehicle. [REDACTED] stated he pushed LAMKIN'S hand away.
8. Also interviewed was [REDACTED] 1641 Indian Falls Road, 762-9339, who is the sister of [REDACTED]
9. MRS. [REDACTED] stated she knew of the incident involving her brother, [REDACTED] and MR. LAMKIN and could only relate heresay that LAMKIN might be a queer. She thought that other boys in the Indian Falls Boy Scout Troop, who have dropped out, might have been involved with LAMKIN. MRS. [REDACTED] was not sure of the Boy Scouts involved.

On July 25, 1977 and until August 4, 1977 I went camping to Nova Scotia with a Mr. Zambini and two friends, [Redacted] and [Redacted]. Mr. Zambini had bought beer, wine and Playboy magazines. The Playboy magazines we had picked up at Mr. Zambini's house. Mr. Zambini had me go to his home and pick up the Playboy magazines saying that the paper bag holding the magazines had my name on it. When I picked up the bag I did notice it had my name on it.

About the third night of camping Mr. Zambini who I was sharing a sleeping bag with, both he and I woke up in the early morning about day break. Mr. Zambini was sleeping with my private. He handed me a Kleenex and told me to roll over and go back to sleep. About a day after this Mr. Zambini apologized to me. I believe because I didn't talk to him. I told my other friends what had happened and to stay away from Mr. Zambini he was queer. On the return home Mr. Zambini had me drive the car several times.
