City Morals Case Probed

Lockport police arrested a city man, Sunday night, less than 10 minutes after they said he forced his way into a home and ordered two girls to remove their clothes under threat of killing their mother.

William H. Winters, 34, of 37 Vine St., was charged with first-degree attempted rape, first-degree coercion and second-degree burglary. He was being held without bail pending a court appearance today.

Lt. Henry B. Newman, chief of detectives, said the man forced his way into an Akron Street home about 9:37 p.m., Sunday.

Police said a daughter started to open the door when the man rang the doorbell and he pushed her out of the way and grabbed the mother by the throat.

While the man dragged the mother into a bedroom, a 15-year-old daughter ran into another room and called for help, police said.

Once in the bedroom, the man forced the 15-year-old and her 14-year-old sister to take their clothes off under threat of harming their mother while he watched.

Before anything further could happen, however, Patrolmen Jeffery St. Onge and Edward Hackett arrived in answer to the call.

The officers said the mother was hysterical and standing at the front door screaming that the man had fled

out the back door when they arrived.

The officers said they followed footprints and apprehended Winters some three houses away from the scene.
