
RE: Telephone call with Larry M. Griffin, Field Director,

Since the information in the material we received did not indicate if the problem was discussed with the individual involved, James A. Poland, we called to secure more background.

When the resignation was requested, the reason was not discussed. However, since the man has had previous problems, it is believed by all in the council that the story of his actions is true.

The parents are demanding that this man get psychiatric help and will probably go to the courts if he does not do it without this action.

There is indication that this man is planning to move his family to Kentucky and has been there making plans.

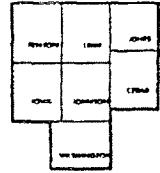

Statement from [REDACTED]

Our son [REDACTED] went on a week end camp-out with Boy Scout troop 117. When he arrived home on Sunday he asked his mother, "Mom why did he suck my penis?" His mother asked him what he was talking about. He told her that Mr. Brown gave him some tobacco and he got sick and did not go with the rest of the boys. He was left with Jim. Jim took [REDACTED] clothes off and rubbed his penis and then sucked it. [REDACTED] said he pretended he was asleep because he was afraid. [REDACTED] said that Jim was shaking. Later [REDACTED] mother was told by Mr. Brown that Jim was in fact Mr. Poland.
