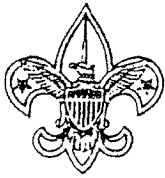

Dear Paul:

All contact with [REDACTED] was made with Dean Klingler the District Executive for the Palm Springs area. All of our dealings were strictly verbal.

[REDACTED] main concern was that the relationship between Mr. McKinney and her son cease. We informed her that our interest would be solely to withdraw the privilege of leadership in the Boy Scouts.

To date, there have been no police reports and consequently no arrest has been made. Our understanding is that there will be no charges pressed.

Marlin Bates reviewed the situation with the Bishop for Mr. McKinney's Latter Day Saints Ward and the Bishop is now working with Mr. McKinney.

The Bishop did not indicate that he had any knowledge of a previous problem.

To my knowledge, no adult leader from Troop 63 attended camp <sup>conversion</sup> last week-end. This being the case, I think [redacted] should have been assigned to some other unit or adult after completing his ordeal. Possibly a very unfortunate and traumatic experience could have been avoided if this been done. A fatherless twelve year old does not possess the wisdom to handle a homosexual.

I wish to take whatever action is necessary to see that Mel McKinn not only is disassociated completely from the Boy Scouts of America but also that he is no longer in a position to jeopardize the activities of any young camp.

During "Breakfast" by use of sign language he asked me what my name was and when my Birthday was. During this time he had been periodically hugging me.
