
Dear Mr. Hall:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the Boy Scouts of America seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you seek to have this decision reviewed, please write to me. I will then see to it that a committee of three Boy Scout volunteers meet with you to consider your case.

I would like to inform ~~up~~ ever is in charge, that on the camping trip this summer to Michigan everything was going fine until the boys were left in charge of a certain Mr. Jerry Hall. On the day before they were to return to Chicago I had a phone call from my son [REDACTED]

[REDACTED] He asked me to please pick him up because he had been beaten by Jerry Hall. My son and his friend were so scared they had to sleep in the woods. Mr. Hall accused [REDACTED] of tearing up a book which he did not do. [REDACTED] was entering his tent where Jerry Hall gave him a head lock, punch him in the head and the stomach and lower yet for some reason he sprayed my son's face with mace (tear gas). He almost choked but his friend helped [REDACTED]

[REDACTED] When we arrived in Michigan, [REDACTED] and his friend had been waiting at the staff headquarters

and he pointed out who Jerry Hall was. We asked Mr. Hall what had happened? He had a smile on his face and he did not deny anything that happened. I was so nervous, I did not report it to the police in Michigan, but we arrived in Chicago on Sat, July 26th at 1:00 a.m., that same morning we made a police report. I also came back with [REDACTED] with his mother's permission cause he was afraid to stay.

[REDACTED] told me that Mr. Hall tried to get funny with him and some of the other boys. When he tried touching [REDACTED] in his personal places, he would get away. There was also a picture of Mr. Hall in the nude ~~found~~ found in the boys' tent. I have the tear gas at home. After the beating the boys spend the night in the woods alone with no food until we come to pick them up the following day. I do not believe that Mr. Hall is a good example for the Boys Scout of America.

Dear Sus:

On July 25, 1975, I received a call from my son, [REDACTED], asking permission to come home from Summer Camp, one day earlier than planned.

I was puzzled why he could not stay one day longer, knowing how much Summer Camp meant to him.

He informed me he would explain when he came home.

I was not pleased with what he had to tell me.

He informed me that one of the scouts was beaten up and sprayed with Mace, tear gas type of spray by one of the counselors, by the name of Gary Hall.

My son came to the boys' scene and both boys were able to get away and run for help from the staff. The staff listened,

escorted the boys back to camp, had a "talk" with Mr. Hall, and informed the boys they had to stay the night in camp.

Mr. Hall's attitude towards the boys wasn't exactly a friendly one after that.

The boys did not feel safe staying in camp; took their sleeping bags and camped out in the woods. To their best knowledge, other than Mr. Hall, the rest of the staff did not know the boys were out of camp.

The boys stayed away from camp Thursday evening July 24, until [redacted] came to pick them up Sunday, July 25, 8:PM. No one missed the boys, except the immediate camp. (I was also told that Mr. Hall would place his hands all over the boys' body and would try to

place his hands on their private part
(The two boys were not the only ones
for Mr Hall to do that to)

The boys resisted his attempts and
in their opinion, is the reason
Mr. Hall accused [redacted] of
stealing books, which [redacted] denied doing
[redacted] my son, was
guilty by association.

In addition, my son found
a nude picture of Mr. Hall on his
slung bag. Unfortunately, he was not
mature enough to keep it for evidence
he tore it up and threw it away.

All of this was reported to the
"staff" and they still send the boys
back to camp. In my opinion, this
was very poor judgment.

Discipline is necessary, granted, but
it is in Mr. Hall's fashion, now is it
necessary to know what the counselors look
like in the nude [redacted]
