I have just completed an investigation into the above Scouter of the Ore-Ida Council as follows:

Offense Report - DR/75-85, April 9, 1975. Lewd and Lascivious Conduct with child.

Conduct was with 4 boys, ages 13, 14, and two at 16 years of age.

Acts committed on January 25, 1975, March 21, 1975 and March 28, 1975.

Warrent charging seven (7) counts of Lewd Conduct were acquired.

Mr. Bill Hagen admitted to one count - others were dropped.

Convicted - served 120 days in State Institution and received 9 years probation.

I personally checked the above records and they would be available under court order if needed, plus the Sheriff stated he would testify if asked.


