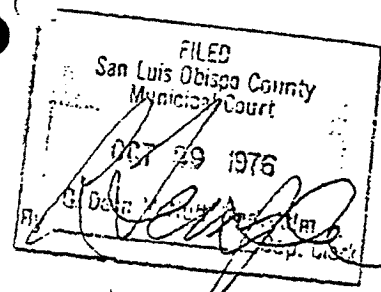



It is therefore our official request of you to sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone. We reserve the right to suspend registration whenever we have a concern about an individual who may not measure up to the high standards of leadership in which BSA seeks to provide for American youth. Always also understand that this decision and the reasons for it are maintained in strict confidence.

If you wish to have our decision reviewed, please inform us by returning your version of the facts supporting your claim that our registration as a BSA leader should be continued in writing at the
