... sentenced for sexual abuse of boy, 11

A 48-year-old man drew an eight-year penitentiary sentence Tuesday after pleading guilty to charges of sexually abusing an 11-year-old boy at the man's mobile home in Crowley.  
Vernon Wayne Ward, a forklift mechanic with no prior police record, was handed the sentence by Criminal District Court No. 4 Judge Gordon Gray during a brief proceeding.

Ward did not contest the testimony of the boy or the evidence presented by prosecutor Charles Roach.  
Ward said in a statement that neighborhood children began hanging around his mobile home in 1979 and finally found his cache of obscene items.  
He admitted abusing the boy on Sept. 26, 1979.
