Boy Scout Leader Held As Pervert

County police are holding a 24-year-old Dundalk scoutmaster in the Towson jail on \$5,000 bail on five charges of performing perverted practices on boy scouts, one on an overnight hike.

Held for action by the Baltimore County Grand Jury is Joseph A. DiBartolomeo, 7300 block Wenig Ave., an employee of Armco Steel Corp.

The scoutmaster was arrested yesterday by county police after indictments in the form of bench warrants were issued for his arrest following complaints by four members of Troop No. 274, Boy Scouts of America, who said they were forced to perform the acts in order to pass scout tests.

THE SCOUTS, age aged 7, 12 and 14, police said.

One attack took place police said, while on an overnight hike last summer. The other assaults, police explained, were in the months of Nov. 10, 23 and as recently as Feb. 14.

One of the scouts told police of being assaulted by his scoutmaster after DiBartolomeo promised to take him to a movie but instead wound up parking on Merritt Blvd. in Dundalk. The boy told police the man gave him whisky during that time.

DiBARTOLOMEO, police said, has been working with young boys for a couple of years and that Troop No. 274 met weekly in a Dundalk church.

Police said that all four boys were told that in order to pass scouting tests, they had to submit to the alleged attacks.
