DETAILS:

At 6:05pm, 10-4-68 Detectives Messick and Cook were contacted by Mr. [REDACTED], Sr. 806 Bell Dr. PE2-2059, who requested that we come to his residence.

At 6:15pm, at the residence, he advised that he had just found out that his two sons, [REDACTED], Jr. wm9 dob 12-2-59 and [REDACTED] wml1 dob 6-22-57 had been molested by MORRIS MARLOW, 802 Bell Dr. PE2-7623.

The boys both stated that MR. MARLOW had committed oral sodomy on them and advised that they would give written statements to this effect.

Mr. MARLOW who is a civil service employee at TAFB (Ext 6960) lives with his mother and is her sole support. He had never been married and has stated on several occasions that he does not like women. He has also served as scout master of Troop 41.

Mr. Walden advised that on Aug 13, 1968 MR. MARLOW had spanked [REDACTED], Jr. with a fly swatter leaving large red welts on his legs. Mr. Walden also advised that several boys were involved. These boys at the time, were all members of Troop 41.

At 6:40pm, 10-4-68 Mr. [REDACTED], present scoutmaster was contacted and he provided address and phone number of the boys. Mr. [REDACTED] resides at 6505 S.E. 15 (PE7-4159).

It was learend that MR. MARLOW is "Big Brother" to [REDACTED], 644 S.E. 20th, ME4-8135.

We asked the [REDACTED] to try to ascertain the exact dates on which the incidents took place and to bring the boys to headquarters at their earliest convenience to give the statements.

At 8:07pm, 10-4-68 we contacted Don Stinnett, 523 Foster Pl, PE2-4318 and advised him of the situation. Both he and Mrs Stinnett had suspicions and took their boys out of the troop. Larry, wml2 dob 2-20-56 and Ricky, wml1 dob 4-3-57 both stated, upon questioning that they had not been molested by MR. MARLOW.

AT 6:40pm, 10-5-68 we contacted Mrs Edith L. Johnson, 3128 Del Rancho Dr. OR7-8161. Johnny, wml2 dob 6-9-56 also advised in the negative as did Robert wml3 dob 6-3-55 and Randall, wml2 dob 7-16-56, Blanton after we explained the situation to them and Mrs Inez Blanton, 3108 Beechwood OR7-3627 at 7:00pm 10-5-68.

At 7:20pm 10-5-68 we contacted [REDACTED] at 807 Bell Dr. PE2-1849. His son [REDACTED], wml2 dob 4-5-56 admitted that MR. MARLOW had committed oral sodomy on him

at the MARLOW residence and that MR. MARLOW kept obscene pictures in the glove compartment of his car. [REDACTED] also advised he would give us a statement.

AT 7:55pm 10-5-68 Harvey Weaver, 911 Bell Dr. PE2-5907 and his two sons Mike, wm9 and David, wml3 were contacted and both boys advised negative.

At 6:00pm 10-7-68 [REDACTED] came to headquarters and gave us a written statement as did the two [REDACTED] at 8:15pm.

At 9:15pm 10-7-68 we went to the residence of Mr & Mrs Pat Brophy at 4112 Ridgeway (no phone). Mrs Brophy is the mother of [REDACTED], wml2, dob 3-31-56 who was in the same scout troop with MR. MARLOW and had spent the night on several occasions at the MARLOW residence.

[REDACTED] advised that on a Friday night the first part of May 1968, he and [REDACTED] and [REDACTED] along with [REDACTED] and [REDACTED] went to the races at the fairgrounds with MR. MARLOW. Upon returning to the MARLOW residence, [REDACTED] and [REDACTED] went home but He, [REDACTED], and [REDACTED] and [REDACTED] were to spend the night in a tent in the MARLOW's backyard. The time of this incident described as the first part of May was established by [REDACTED]'s mother and step father as they had moved from Midwest City to DelCity on May 23rd and the last time that [REDACTED] spent the night with MARLOW was at least three weeks prior to their moving.

In the tent the boys were asked to take their clothes off and submit to the oral sodomy and various other sexual acts. The attached statements reflect the nature of these acts.

At 10:55pm, 10-7-68 we contacted Mrs [REDACTED] at 644 S.E. 20th ME4-8135. Her son [REDACTED], wml4, dob 7-21-54 stated he had not been touched by MR MARLOW. Mrs [REDACTED] stated that she doubted this as [REDACTED] had spent so much time with MR MARLOW. She believed that [REDACTED] was trying to protect MR. MARLOW as he was [REDACTED]'s "Big Brother" and had given [REDACTED] a new bicycle besides taking [REDACTED] on many outings.

[REDACTED], wml5, dob 1-29-53 stated that he knew [REDACTED] was lying, also that several years ago while Larry was attending Heronville School he met MR. MARLOW and on many occasions since, MR MARLOW had committed oral sodomy and other sex acts with him.

We asked [REDACTED] to try to remember all the dates and times he could and give a written statement. We advised that since it was so late, we would give him a chance to remember and return after 6:00pm 10-8-68 for the statement.

[REDACTED], wml6 dob 2-23-52 stated that the oral sodomy had been performed on him by MR. MARLOW.

All statements will be attached.

The District Attorney will be contacted reference the matter and decision will be made as to whether criminal charges or a petition for a mental hearing will be filed.

Investigation will continue.
