The Upper Darby Police have this man in custody for a hearing which occurred on May 1. He has already pleaded guilty to sodomy involving four teenagers with a prior arrest on his record of mugging while in military service. He is 33 years of age, white, and his religious belief is Greek Orthodox.

The police have promised to give us the details of the hearing which we will forward at a later date.
