I Robert M. Peterson do hereby swear that all things that I write are true to the best of my knowledge. I started this questioning of the boys in January and it was my method of striking back at some of my family problems. I stopped after the last boy as I became aware that it was a form of embarrassment to the boy and I realized that I did not want this. I am truthfully sorry that it happened and that I was stupid enough to think that it would go unnoticed. I don't recall the exact questions verbatim but they were all related to his (the boy) personal sex habits of which I realize now that were none of my business. I used my trust as a scout leader in talking with the boy and realized that I betrayed that trust. The boys that performed this for me [redacted], [redacted], [redacted] and [redacted] refused. I asked them to stimulate to erection and masturbate in front of me.

I hereby resign from any connection with the boy scouts of america and that I will not attend any scout functions or any other meetings.
