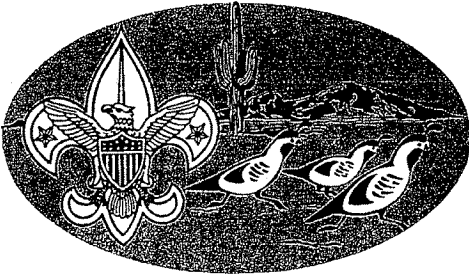

- FOR THE CONFIDENTIAL FILE.

PHYSICAL DESCRIPTION: Subject is 5 ft., 8 in. in height, light brown hair, hazel eyes, 158 lbs., medium build and complexion. No information given as to scars, birth marks, or physical blemishes on subject.

DATE OF BIRTH: April 4, 1938. Subject is male, and a Caucasian.

HOME ADDRESS: 4744 N. 50th Avenue, Phoenix, Arizona.

PRIOR ARREST RECORD: On January 2, 1960, Mr. Sargent was arrested on a charge of Sodomy, 3rd Degree, in Syracuse, New York, and received a 3-year suspended sentence. This information was obtained from an FBI "Rap Sheet".

CURRENT ARREST AND CONVICTION: Mr. Sargent was arrested February 11, 1969 under Criminal Complaint No. 44639, on the following charges:

Count I: Child Molest

Count II: Lewd and Lascivious Conduct

The complaining witness was [REDACTED], 4345 N. 50th Drive, Phoenix, Arizona. The complaint was issued in Justice Court, Tolleson Precinct, County of Maricopa, State of Arizona, and was signed by Justice of the Peace VERNON E. SESSIONS.

The complaint read as follows: "THOMAS GEORGE SARGENT did then and there feloniously molest one [REDACTED], being then and there a child under the age of 10 years of age, and in violation of Arizona Revised Statutes 13-653, 1965."

At the time of this offense, [REDACTED] was a Cub Scout, registered in Pack 167, sponsored by Andalucia School Parent-Teacher Association, 4701 W. Campbell Avenue, Phoenix, Arizona, 85031.

Also, at the time of this offense, THOMAS GEORGE SARGENT was a registered Webelos Leader for Pack 167.

RESULTS: A Judgment of Guilt and Order for Probation in the Superior Court, County of Maricopa, State of Arizona was granted on the 21st day of August, 1969. The abovementioned order read, "It is the judgment of the Court that the Defendant, THOMAS GEORGE SARGENT, is guilty of Count I, lesser included offense of Aggravated Assault as judged. It is ordered suspending of imposition of sentence for a period of one year from this date, and the defendant is placed on probation under the specific conditions that the defendant seek psychiatric care, and with further terms and conditions as set down by this Court, which have been reduced to writing, and the defendant will sign a copy of these terms and they will become a part of the Court Record."

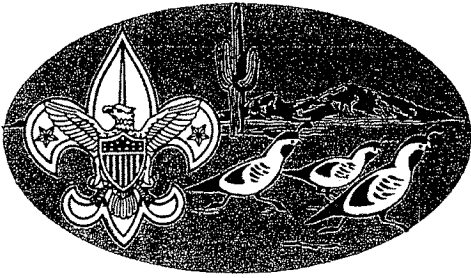
Hon. Judge Jerry H. Glenn, Division 17, Superior Court, was the presiding judge.

SUBJECT: Additional Information on Thomas George Sargent for the
Confidential File. SUPPLEMENTAL REPORT.

Mr. Sargent had a boy, Bryan T. Sargent, 4744 No. 50th Avenue, Phoenix, registered in Pack 167 - December 1968. According to reliable sources, at the time of the incident, the boy dropped out of the unit. According to reliable sources, Mr. Sargent was employed as a truck driver, or a truck loader. The family consisted of one boy, Bryan; a one-year old girl, and a small baby. The wife's name is Retha. Mr. Sargent was a man described as very clean in his habits, and a "beautiful personality". The source further states that he was "very clever".

At the time of the incident, the wife was working at the Motorola Semiconductor Plant in Scottsdale, Arizona, and described as a "cool, collected individual". The source also stated that Mr. Sargent could "read people very well." An example of this is as follows:

The boy in this incident had emotional problems and acted as if he were retarded. This source states that Mr. Sargent saw this and made it a point to be friendly with this youngster. Whether Mr. Sargent had any prior ideas of molesting the youngster is not known.

At the trial, Mr. Sargent was given a polygraph test (Lie detector). Mr. Sargent was also examined by a Court-appointed psychiatrist. The Plaintiff's child was also given a polygraph test and examined psychologically.

The above mentioned information was primarily developed from the Committee chairman of Pack 167, who is still the Committee Chairman of this Pack.

It is considered by me that this information is from a reliable source, and not "colored".
