GENTLEMEN:

THIS IS TO RECOMMEND THAT JACK J. TALAMO, 22 MAC ARTHUR ROAD, BALDWINVILLE, NEW YORK, BE PLACED ON THE "CONFIDENTIAL" LIST, THAT HIS PRESENT COMMISSION BE CANCELLED AND THAT HE NOT BE COMMISSIONED IN THE FUTURE. JACK J. TALAMO, WHILE SERVING HIS SECOND YEAR ON THE CAMP STAFF AT CAMP 12 PINES, WAS ACCUSED BY A LEADER AND A SCOUT OF HAVING ENGAGED IN SEXUAL MOLESTATION OF A BOY AND WAS IMMEDIATELY DISCHARGED AND REMOVED FROM DUTY. SHORTLY THEREAFTER HE ADMITTED TO CAMP DIRECTOR, LEIGH N. JERRED, THAT THIS ALLEGATION WAS TRUE AND THAT THERE HAD BEEN OTHER INSTANCES DURING HIS PERIOD OF SERVICE ON THE CAMP STAFF AT CAMP 12 PINES.

THIS MAN IS REGISTERED WITH THIS COUNCIL AS A COUNCIL MEMBER AT LARGE AND I UNDERSTAND THAT HE IS ALSO REGISTERED WITH THE ONONDAGA COUNCIL AS A SCOUTMASTER OF A TROOP IN BALDWINVILLE, NEW YORK. HE IS LISTED AS A PREVIEW CANDIDATE FOR PROFESSIONAL SCOUTING.

UNTIL RECENTLY HE HAS BEEN A LIFE LONG RESIDENT OF OSWEGO, NEW YORK AND A SCOUT IN THIS CITY. HE ATTENDED POTTS DAM COLLEGE AND IS A MUSIC TEACHER. HE HAS BEEN TEACHING IN THE BALDWINVILLE PUBLIC SCHOOL FOR THE PAST SEVERAL YEARS. HE HAS SERVED 2 YEARS' ENLISTMENT IN THE U. S. ARMY. *separated June 1956*

IN RECENT YEARS HE HAS BEEN ASSISTANT SCOUTMASTER AND SCOUTMASTER IN OSWEGO WHILE COMMUTING TO HIS WORK AT THE BALDWINVILLE PUBLIC SCHOOL. HE IS 30 YEARS OF AGE, MARRIED AND HAS 3 DAUGHTERS.

THE FATHER OF THE SCOUT INVOLVED IN THE INCIDENT DOES NOT WISH TO HAVE HIS BOY SUBPOENAED AS A WITNESS IN A CASE OF THIS KIND AND THEREFORE HAS DECLINED TO BRING ANY CRIMINAL ACTION. THE BOY APPARENTLY WAS NOT HARMED AND WHILE ANGRY, SEEMED TO THINK ABOUT THIS INCIDENT VERY LITTLE.

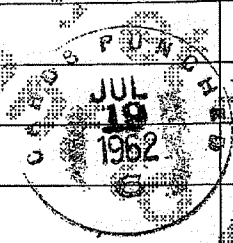
