Dear Judge Rector:

The above named, 23 year old black, single male, was seen from the psychiatric standpoint at your request on April 17, 1970. This individual when seen presented the appearance of a husky black male who came to the appointment dressed in his work clothes, inasmuch as he left his job to come to the interview. The individual stated that he had been working at the Chevrolet Plant for approximately one year and at the present time was working the first shift. The individual at the time of the interview spoke in a coherent and well modulated voice. He did not recall having been to see the examiner previously, but stated that he recalled having been charged with "prg sodomy" in 1965. The individual stated that he was here for a similar charge. He state "this time I gave a guy a blow job. I had my scout troop out at Camp Redwing about five weeks ago during the first part of March. It was on a Saturday night. We got to telling jokes first and then one of the guys started to jack off. We all got to playing around, hitting each others penises. Then I sucked off three of the boys." Patient without any trace of embarrassment mentioned the name of the young men with whom he had oral relationship, these individuals all being youngsters who evidently were members of a scout troop, the accused being the assistant scoutmaster for this troop. The individual stated that the boys did not complain about the acts which had been carried out. He further added that this was only the second occasion that he had carried out such oral sexual acts, stating that the first occasion had been in 1965, when he had been arrested previously. He also added that the camping experience that he had with the troop was the first experience he had had since he had become assistant scoutmaster. The individual stated that the sexual acts had occurred on Saturday night and that the troop had returned to their homes on Sunday. He further stated that he went to work as usual on Monday and was arrested by police as he left work that afternoon, being jailed in the County Jail for eight days at which time he was released on bond.

The individual repeatedly denied having desires or urges to carry out oral sexual acts such as the above with anyone prior to the above occurrence. He, however, stated that he had been masturbating approximately three times a week, fantasies during the masturbation being centered about girlfriends that he had had in the past. The individual denied having fantasies sexual in type which were directed towards the same sex. The individual also denied frequent sexual dreams. He denied homosexual dreams at any time but stated that at times he dreamt about having relationship with the opposite sex. The individual denied any homosexual activities with other men such as which might occur while the individual was drinking, at local bars, etc. The individual gave a history of serving in the U.S. Army from March 3, 1966 to February 28, 1969. He spent approximately one year in Viet Nam but did not see combat. He also saw 18 months of service in Panama during the year 1967 and 1968. The individual received an honorable discharge from the service and denied court martials. He denied homosexual contacts with fellow servicemen, but readily admitted that he had been the passive partner in oral sex acts on four different occasions while overseas, these evidently being with civilians. He did not acquire venereal disease during his military service. The individual readily admitted having frequent sexual relationship with natives, both in Viet Nam and Panama. Without hesitation, when asked about his sexual urges, he stated that he preferred having relationship with a woman to doing a blow job, but he stated that gratification from the sexual act or from being the passive partner in oral sexual acts rated about the same. Sexual history since discharged from the service, according to the patient, has been rather limited in reference to the opposite sex, patient stating that he did not have opportunities to make contacts because of the hours which he worked. The examiner finds it rather difficult to believe such a statement, inasmuch as he has been working only five days a week, and if he wished would have plenty of opportunity to have contacts with the opposite sex. The individual also gave a history of excessive drinking but he admitted he denied intoxication Sunday to same. In fact, he stated that he became intoxicated on only one occasion during his military service, this being when he celebrated returning home from Viet Nam. The individual tried smoking marijuana on one occasion in Viet Nam and a second occasion in Panama. He stated that smoking this drug made him ill and as a result he did not try it further. He denied usage of hard drugs.

The individual's past sexual history is essentially as obtained by this examiner in 1965. At that time the individual gave an interesting sexual history which he again verified as being a true one. On that occasion he stated that he started to have sexual contacts with the opposite sex at the age of 5 years and that he had had sexual experiences with the opposite sex every week or two from that period on. The individual described himself as having had numerous girlfriends over the years. He gave a history of being the passive partner in oral sex acts at the age of 7 years, at which

Dear Mr. Olson:

Please forgive me for the delay in replying to your letter of April 8 concerning forms for the confidential file cases. Enclosed are the confidential record sheets you requested.

In addition to the information asked for, we would like you to send us as much substantive material on the case as you can. If you have any newspaper clippings, they will be helpful. We would also like to have definite information as to the disposition of the cases in court.

You have also asked for copies of an explanation of the Confidential File. We do not have any definite form statement on this subject. I am at a complete loss as to what #A936 and #A9381 are.

Following is some information which should be helpful to you in discussing our Confidential File with your local prosecutor.

"The Confidential File is a listing of names and records of individuals who, because of a lack of integrity or loyalty, or a moral or mental weakness, have proven themselves undesirable as associates or leaders of boys and a detriment to the Boy Scouts of America.

When the evidence justifies placing an individual on the file, this action prevents his future registration as a leader in the Boy Scouts of America unless he is cleared at some later date. The file also serves as a medium through which local councils may make inquiries concerning acceptability of leadership applications.

When ever evidence is produced that a man has proven himself unfit as a leader of boys in the Scouting program, his name is listed in the Confidential File.

"In every case, there must be substantive information supported by whatever may be available in the way of factual data, such as police and/or court records, written statements from boys and/or parents, newspaper articles, affidavits, etc.

Many local Boy Scout councils have a close working relationship with municipal, county and state law enforcement agencies and are thus able to obtain needed information. This also applies at the National level with federal agencies."

I am sure you understand that all matters concerning the Confidential File need to be handled with the greatest of care and in the most discreet manner. Improper handling of confidential file cases could bring great embarrassment to the Boy Scouts of America and even legal action.
