In trying to trace down Ronald Kidd's registration in Scouting, we find a Theodore Kidd, 6421 Snider Road, Loveland, Ohio, currently registered as merit badge counselor in District 7. Since Mr. Kidd's age is listed as 40, are we correct in assuming that this is Ronald Kidd's father? In order to complete our records regarding this situation, we would very much appreciate your advising us of Ronald Kidd's current status in the Scouting program, so that we may delete his name and separate him from the unit. Thanks for your help.

On the bottom of your record sheet you indicate "After a long investigation by a council member who is former chief of police, we have found four men who should not be in this movement. See attached letter."

We have carefully read the letter which was attached, photo of which is enclosed, and can find no reference to any four men who should be placed on the file. What is the story? We would appreciate your writing us a more detailed letter, with as complete a report as possible regarding this, so that we may determine just how to handle the situation. Sorry to bother you with this, but the information you have given us is not sufficient for us to take any action.

Upon a call from Mr. [REDACTED], I picked up [REDACTED] at his home in Norwood and accompanied him to Mr. Schrotel's office in the Kroger Building.

I sat in on the conference and witnessed the fact that [REDACTED] did state to Mr. [REDACTED] the bare facts pertaining to what had happened when Ron Kidd invited him to his home. Those facts were that he had him sleep with him and take part in acts of immorality.

[REDACTED] stated that he had told no one else about this except [REDACTED] and Mr. [REDACTED].

He also stated that following the act, Ron Kidd was brazen enough to say that he was not to worry about it or he might have a nervous breakdown like another boy in his troop had had. Ron Kidd also made the statement that he would do it again.

These statements were all made in my presence to Mr. [REDACTED] by [REDACTED].

The above information is strictly confidential and should be kept so.





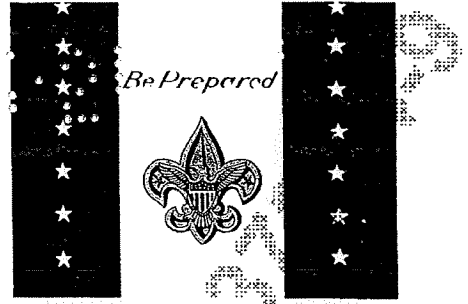
