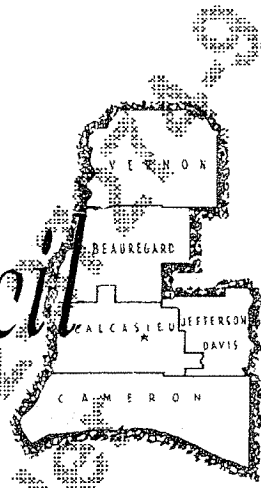

Dear Howard:

This is to place Mr. Ronald Benoit on the Red Flag List. He has been convicted of perversion and is now serving a term in the penitentiary.

We are happy to say that as far as we can determine, that he was not involved with any Scouts. This young man has come up through Cubbing and Scouting in this council, been registered as an Assistant Scoutmaster through 1961. He went into the military and was registered in Troop 6 in Herzogenaurach, Germany, in 1961 and 62. (We figure this hitch in the military is where he went wrong.) After returning from the military he was registered as a merit badge counselor in this council from June, 1963, to June, 1964. *not on any registers in file*

He was in jail for a long time before his trial and under these circumstances I didn't report him and then forgot it for two or three months.

His name is Ronald Benoit. He is 25 years old, unmarried, about 5'8" tall, very fair complexion, pink cheeks and almost "pretty". His hair is sandy blond, weight about 155-165 pounds, quite personable.

Race -- white; religion -- Catholic. He previously resided at 2507 Dietz St., Lake Charles, La.

Since this young man has been in Scouting and Cubbing most of the time since 1950, it is quite probable that he will attempt to get back in at another city after he is released from prison.

We believe that this is about all the information you will require, but if you need more, don't hesitate to call on us.
