GENERAL COURT-MARTIAL ORDER
NUMBER 2

7 January 1964

Before a general court-martial which convened at Frankfurt am Main, Germany, pursuant to Court-Martial Appointing Order Number 71, this headquarters, 14 November 1963, as amended by Court-Martial Appointing Order Number 75, this headquarters, 12 December 1963, was arraigned and tried:

SPECIALIST FOUR (E-4) FREDERICK E. CLARK, RA 13 730 372, U. S. Army, 118th Medical Detachment, APO 171, US Forces.

CHARGE: Violation of the Uniform Code of Military Justice, Article 134

Specification 1: In that Specialist Four (E4) Frederick E. Clark, US Army, 118th Medical Detachment, APO 171, US Forces, did, near Bad Hersfeld, Germany, during the period from 6 August 1963 to 11 August 1963, commit a lewd and lascivious act upon the body of [REDACTED] Junior, a male under sixteen years of age, by placing his hand upon the penis of [REDACTED] Junior, and fondling it with the intent to gratify the sexual desires of the said Specialist Four (E-4) Frederick E. Clark.

Specification 2: In that Specialist Four (E4) Frederick E. Clark, US Army, 118th Medical Detachment, APO 171, US Forces, did, near Bad Hersfeld, Germany, during the period from 6 August 1963 to 11 August 1963, commit a lewd and lascivious act upon the body of [REDACTED], a male under sixteen years of age, by placing his hand upon the penis of [REDACTED] and fondling it with intent to gratify the sexual desires of the said Specialist Four (E-4) Frederick E. Clark.

Specification 3: In that Specialist Four (E4) Frederick E. Clark, US Army, 118th Medical Detachment, APO 171, US Forces, did, near Bad Hersfeld, Germany, during the period 6 August 1963 to 11 August 1963, commit a lewd and lascivious act upon the body of [REDACTED], a male under sixteen years of age, by placing his hand upon the penis of [REDACTED] and fondling it with intent to gratify the sexual desires of the said Specialist Four (E-4) Frederick E. Clark.

Specification 4: In that Specialist Four (E4) Frederick E. Clark, US Army, 118th Medical Detachment, APO 171, US Forces, did, near Bad Hersfeld, Germany, during the period from May 1963 to 11 August 1963, commit a lewd and lascivious act upon the body of [REDACTED], a male under sixteen years of age, by placing his hand upon the penis of [REDACTED] and fondling it with intent to gratify the sexual desires of the said Specialist Four (E4) Frederick E. Clark.

In the foregoing case of Specialist Four (E-4) Frederick E. Clark, RA 13 730 372, 118th Medical Detachment, U. S. Army, only so much of the sentence as provides for dishonorable discharge, forfeiture of all pay and allowances, confinement at hard labor for two years, and reduction to the grade of Private (E-1) is approved. The forfeitures shall apply to all pay and allowances becoming due on and after the date of this action. The record of trial is forwarded to The Judge Advocate General of the Army for review by a board of review. Pending completion of appellate review, the accused will be confined in the United States Disciplinary Barracks, Fort Leavenworth, Kansas.
