# Scout Leader Arrested On Morals Count

A prominent St. Albans Boy Scout leader and one-time candidate for alderman was arraigned in Franklin Municipal Court late this morning, charged with lewd and lascivious conduct.

John D. Comstock of Oak Street, cubmaster of the Holy Angels Parish pack, appeared before Municipal Court Judge Carl S. Gregg minutes after he was released from the St. Albans Hospital, where he had been for sev-

eral days.

A plea of innocent was entered in his behalf and he was immediately taken from St. Albans to the state hospital at Waterbury for observation.

The 35-year-old disabled war veteran was arrested by city police upon his discharge from the hospital. He was arrested on a complaint issued by Franklin County State's Attorney William B. Goldsby.

The complaint, according to Police Chief George E. Hebert, was issued yesterday morning and held until Friday.

The charge, a felony, carries a prison term of from one to five years.

The arrest followed a weeklong investigation started by Franklin County Sheriff John R. Finn and turned over to city police on Sunday.

The complaint alleges that acts of lewd and lascivious conduct were carried on by Comstock with "diverse boys" and upon "diverse occasions."

Comstock has been active in local scouting for a number of years.

His pack has been presented with several state awards and has figured prominently in scouting activities.

Two years ago, Comstock was a Republican candidate for alderman of Ward 3. Earlier, he had been mentioned as a possible candidate for the School Board. (See MORALS, Page 2)

Sheriff Finn and Chief Hebert said this morning they have obtained signed statements from parents of boys with whom the alleged offenses occurred.

Comstock was admitted into the St. Albans Hospital Tuesday night. No reason for his confinement was given.

## Comstock's Sentence Is Suspended

John Comstock, 33, former St. Albans Cub Scoutmaster, was given a two - to - three year suspended sentence in Franklin Municipal Court Friday, after he changed his plea from innocent to guilty on a charge of lewd and lascivious conduct involving boys under 16.

One of the terms of his suspension was that Comstock not associate with persons under the age of 16, and further that he not return to the St. Albans area.

Comstock was also ordered to pay court costs of \$95.30 through the probation department.
