**Molester of Boy Goes to Hospital**

A Carpinteria man who pleaded guilty to a morals offense involving a 10-year-old boy was declared a sexual psychopath yesterday afternoon and was sent to Atascadero State Hospital.

After hearing testimony of two doctors, Superior Judge W. P. Butcher sent Paul Doner, 29, to the hospital for a 90-day observation period.

According to a Probation Department report, Doner was scheduled to have gone to work as a cook at a Boy Scout camp at Lake Cachuma, but he was arrested first. The boy involved was not a Scout.
