Arrest 10 Men for Illicit Sex Activities in City Area

Waukesha plain-clothes detectives who staked out a Frame park restroom after learning it was being used for illicit sex activities, have arrested nine men. The men have been charged with sexual perversion or disorderly conduct.

Charged with sexual perversion in municipal court today was Boyd B. Burnside, 53, of 109 N. Charles st., dean of men at Carroll college. Preliminary examination was set for a week from today.

He was arrested Aug. 30 after detectives followed him and Dewaine Books, 23, from Frame park to a rendezvous in a car parked nearby. Books was also charged with sexual perversion.

Others arrested include:

Aug. 19 — Alex Haynes, 39, of 422 W. Wabash av., accountant, and John Beyer, 35, Detroit, former Carroll college athlete. Both pleaded guilty to sexual perversion and were sent to Rogers Memorial hospital in Oconomowoc for psychiatric diagnosis. Beyer is teaching at Grosse Point, Mich.

Aug. 27 — Dale Meyer, 37, of 102 Baxter st., was charged with disorderly conduct after making an indecent proposal to a plain-clothes detective. He pleaded not guilty.

Sept. 2 — Marvin Kocjan, 24, of 237 N. Charles st., an elementary school teacher at Hillcrest school, charged with sexual perversion. Kocjan resigned this week. Also charged with the same offense was Robert Hopson, 43, Waukesha Rt. 1, box 30, vice-president of an oil company. They are scheduled for preliminary examination Friday in municipal court.

Sept. 5 — The Rev. George

Huber, Milwaukee Roman Catholic priest, who pleaded not guilty today to disorderly conduct. He is attached to SS. Peter and Paul's church, Milwaukee. William Hockett, 22, of 407 Evergreen ln., Pewaukee, a mail carrier. Hockett is scheduled for a preliminary examination after pleading guilty to disorderly conduct.

A tenth man in municipal court today, A. Willis Bolt, 53, a Milwaukee dentist, was fined \$100 and costs after pleading guilty to disorderly conduct. Bolt was arrested after a 19 year old boy told police Bolt walked up to him in Cutler park Sept. 2, talked of homosexual activities, and asked the youth to meet him later.

The park stakeout by the detective bureau won praise today from Police Chief Moody Walter, who called it "wonderful police work." Six detectives were at the park nightly for the past two weeks, sometimes on duty from 8 p.m. to 4 a.m.

THE FREEMAN and Milwaukee papers agreed to withhold news of the arrests and stakeout at the request of Walter and Dist. Atty. George E. Lawler, who said premature release might hurt their investigations.

Lt. Robert Goetzelman and Capt. Howard Farnish said today that the detective bureau had at least a dozen more suspects that would be questioned within the next week or two.

"There has been an increase in recent weeks and months of homosexual activity in the county," Lawler said today. "The fine work of the Waukesha police department will be a great

help in keeping this kind of thing in check."

LAWLER said those caught in sexual acts were charged with sexual perversion. Those charged with disorderly conduct, he said, had made indecent propositions or were caught short of actual perversion.

"The Waukesha police department will continue to make every effort to apprehend this type of man," Lawler continued. "We have every reason to believe there will be more arrests. Frame park has become known as a center for immoral purposes as far as Milwaukee and Chicago."

According to Lawler, most of the men arrested were not known to each other. He said it appeared that there was an agreement to remain anonymous in order to avoid blackmail.

He added: "There was no concerted plan to the meetings. Individuals apparently simply went into the park and expected to find other individuals. I understand that the advice, 'Go to Frame park, Waukesha,' has been passed around widely among homosexuals in the midwest and has been found written on washroom walls as far away as Chicago and Detroit."

Gets Probation For Morals Offense

A Waukesha resident charged with sexual perversion was placed on two years probation today with the provision he seeks psychiatric treatment.

Alexander G. Haynes, 39, of 422 W. Wabash av., pleaded guilty to the charge in municipal court last month. He was placed on probation after undergoing diagnosis at Rogers Memorial hospital, Oconomowoc.

Haynes was one of the first of 11 men arrested in a police crackdown on immoral conduct in and near Frame park.
