

We, [redacted] and [redacted] twin brothers fifteen (15) years of age, residing at 2920 Cumberland Road, Erie, Pennsylvania, hereby make this voluntary statement to Kenneth Edwards, District Scout Executive, in the presence of our mother, Mrs. [redacted]

We are members of Ship No. 34, of which David Herring was First Mate until approximately October, 1961, when he entered the United States Army. During the summer of 1961, David Herring operated a boat livery at Avonia Beach and lived at a house trailer there. We stayed at the house trailer with David Herring much of the time during the summer of 1961. On numerous occasions during the summer of 1961 at the house trailer occupied by David Herring, David Herring engaged in sexual activity with us by using his mouth on our privates. This was done when both of us were in bed with him and in the presence of each other. Also during the summer of 1961, David Herring stayed at our home, 2920 Cumberland Road, overnight on several occasions and slept with us. The same sexual activity took place on these occasions at our house.

David Herring entered the United States Army in approximately October, 1961. He was home on leave in December, 1961 and stayed overnight at our house several nights during his leave. During this time in December, he slept with us and engaged in the same type of sexual conduct we have described above.

David Herring still writes to us a couple of times a week and in his letters he hints at the things we have done.

We have read the foregoing statement which is true and correct. We hereby sign this statement in the presence of our mother this 26th day of February, 1962.

now in military service, stationed at Fort Carson, Colorado.


We have a statement signed by two Explorers in this Explorer
