Lubbock Man Ruled Guilty

Jurors in 140th District Court found 29-year-old David Marvin Jackson guilty Wednesday afternoon of performing an act of sodomy on a 15-year-old boy and assessed the maximum punishment of 15 years in prison.

Trial of Jackson in another sodomy case is pending in 140th District Court, Judge Robert H. Bean said.

Witnesses called by Asst. Dist. Atty. Bill LauBach and Monty Bray were three boys, one 15 and the other two 16.

Jackson was accused of sodomy in connection with an alleged incident at his residence here at 4401 43rd St. June 1 and involving one of the 15-year-old boys who at the time of the incident was 15.

I would like to submit to your section the names of two men to be placed on our confidential files. Each of these men had been registered in Scouting some time in the past, but are not now registered.

1. Ruben Livingston, Lubbock, Texas; Age, 22; Negro; 5 ft. 8 inches; Single. Was registered in 1962 as Assistant Scoutmaster in Troop #436. Sometimes called Danny. Convicted of sodomy and received a five year sentence.
2. David Marvin Jackson, Lubbock, Texas; Age, 29; White; Single. Registered in 1955 as Assistant Scoutmaster of Troop #12 of Lubbock. Charged with two cases of sodomy and check law violation. Case has not been tried as of this date.
