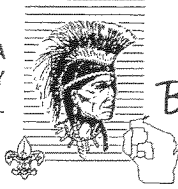

## Menomonie's Ex-Chamber Head Arrested

MENOMONIE (Special) —  
Don L. Sorenson, former executive of the Menomonie Area Chamber of Commerce, was arrested Saturday by Dunn County authorities on a morals charge.

Sorenson posted an appearance bond of \$1,500 set by Judge William Bundy and is scheduled to appear in county court Tuesday morning.

A criminal warrant, issued by Dunn Dist. Atty. William C. Wohlfiel, charges Sorenson with feloniously taking indecent liberties with a 12-year-old boy August 18.

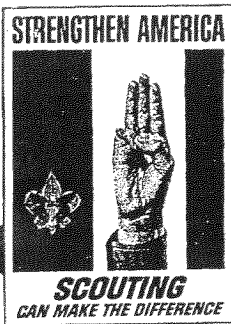
The warrant is based on a complaint signed by Dunn Sheriff Clarence C. Walter.

Sorenson, 27, of 1532 Knapp St., resigned August 30 after serving two years as executive secretary of the chamber of commerce here.
